Legislative Issues

There were two victories on the Former Spouses Act. First the law is changed to consider what the member's rank/income were at the time of divorce and the Supreme Court ruled that a member's VA disability cannot not be factored into the amount due the spouse.

AFSA will have more information on the FY18 Budget after it has been thoroughly reviewed. As with each year there is always discussions on the size of pay raises, Tricare increases for current and future retirees and other items of interest to those in uniform. American Leadership



American Leadership

At the time of this writing the only meaningful pieces of legislation currently being debated in Congress are the American Healthcare Act of 2017, and the President's FY2018 federal budget proposal. I have received many questions about the American Healthcare Act specific to what it means for our families and those on TRICARE. I can assure you that there is no reason for concern whatsoever because the language in the bill makes it clear that the provisions of the bill have no impact on current federally provided healthcare systems such as Military Treatment Facilities, Medicare, TRICARE and VA Healthcare. So until the bill clears the Senate and enters committee to work out the differences in the two bills there is really nothing to worry about. We will continue to monitor the legislation as it works its way through the senate and we will keep you all informed if any changes come to light that would concern our members.

The president's budget marks a rapid departure from the past six years where the Department of Defense was asked to shoulder 50% of budget cuts under sequestration since 2011. Sequestration forced the services to cut personnel, cut back on training, and forgo required maintenance and recapitalization of combat systems after sixteen straight years of constant deployment. The President's budget proposal calls for the complete repeal of sequestration and the restoration of \$52 billion to the Department of Defense.

Perhaps the greatest change in American policy is the reengagement of American leadership around the world. After eight years of withdrawal, appeasement, and apology America has once again accepted the mantle of leadership of the free world. President Trump's first overseas trip made it clear that America will no longer be the world's police force but instead will expect every other country to do its fair share in providing for their common defense. In a stark contrast form years past President Trump also made it clear that America will act whenever necessary and wherever necessary to protect American interests and American citizens around the globe. This will almost certainly mean increased mission requirements and continued deployments for our members and their families.

In years past when discussing global politics with friends of mine from around the world I used to ask the rhetorical questions of "what would the world look like without American in it?" Unfortunately, over the past eight years we learned the answer to that question. In the absence of American leadership, the world has become a much more dangerous place. At no time since WWII has American leadership been more important. The global menace of ISIS, the growing nuclear threat of North Korea and Iran, the expansion of China into the Pacific Rim, and Russian aggression all threaten American interest both at home and abroad.



GivBit: How Much Can You Afford to Give Back?

The "Fitbit" is a popular digital assistant that helps millions around the world strive for better physical fitness by setting their own fitness goals and providing daily updates on meeting those goals. With over 22 million units sold in 2016 alone the concept behind the Fitbit along with its technology has definitely struck a nerve.

Here's how Fitbit describes itself and its product: "When it comes to reaching your fitness goals, steps are just the beginning. Fitbit tracks every part of your day—including activity, exercise, food, weight and sleep—to help you find your fit, stay motivated, and see how small steps make a big impact. Every moment matters and every bit makes a big impact; because fitness is the sum of your life. That's the idea Fitbit was built on—that fitness is not just about gym time. It's all the time. How you spend your day determines when you reach your goals. And seeing your progress helps you see what's possible."

It's really quite simple – through applications available on a smart phone each Fitbit wearer simply chooses their goals and the Fitbit tracks their daily physical activity and compares that to their goals. It's like having a personal trainer handcuffed to your wrist.

Imagine if there was a "Givbit", a digital assistant that helps one meet their personal goals for involvement, engagement, outreach, or just simply the giving of their time and talents to their community. One could look through a variety of applications on their smartphone and find their areas of interest. The list of charities, organizations, and causes available are so huge you'll probably need to upgrade your phone!

Now that you've selected your application(s) it's time to configure your Givbit. How much can you donate a week, a month, a year? Let's say you've determined that you can donate 2 hours per week. That's a total of 104 hours a year — wow that sounds like a lot! But thanks to your Givbit, you'll be able to manage and track your time. As you start to volunteer at your favorite activity you soon see that 2 hours a week is not enough. The need in your community is so strong (and your desire to make a difference is even stronger) so you decide that you can donate 4 hours a week or 208 hours a year. A quick update of your Givbit app on your smartphone and you are on your way. Life happens, interrupting our Fitbit goals and interrupting our Givbit goals as well. No problem, as we're able to make up for those lost efforts and get back on track.

One important feature of the Fitbit is its heart rate monitor. We all know that exercise is of little value if we fail to get into our target heartbeat range based on our age and sex. Likewise our Givbit needs a similar feature: the "in your heart" rate monitor. Giving of your time and talent is of lesser value when your heart isn't in it or worse yet you're only doing it for your performance report, quarterly or annual award or just simply to get your supervision off your back. So, our Givbit will only count your giving when you reach that "it's in your heart" level.

My Givbit apps would be Church Music (I play in our praise band), Tithing, Donations to a food bank, Supporting the Airmen in my squadron (ALS graduations, parties, events), AFSA (Chapter 951's Honoring Our Patriots concert, POW/MIA 5K, legislative events, monthly meetings, and Division 3 business). Wow, that sounds like a lot...but is it? Music: about 150 hours a year between services and rehearsals; Supporting the Airmen: about 30 hours a year; AFSA: about 200 hours a year; for a total of around 380 hours. The tithing and donations are of course monetary and physical donations. For those familiar with Chapter 951, you'll notice that I did not include our veteran's home outings, highway cleanup, or family events into my Givbit goals. No, I'm not shirking responsibility, I'm maintaining balance in my life.

You must set time aside for other priorities such as your job, your family, and for yourself. When someone puts themselves into every event, every cause, every function they will burnout and not provide their very best to those moments. Plus, always being "the guy" or "the gal" feeds into the "STP" (Same Ten People) situation that stifles individual and team growth.




















Chapter 804 The Heartbeat of America Chapter




