

Membership Recruiting/Retenion



Hello from your Division 3 Membership Trustee,

I have been working retentions for many years and I have noticed a lack of renewals the past couple of years. If you look at the numbers, you will see three Chapters only had one renewal each. This year, as in the past years, there are three Chapters that stand out—

- 804 (Kansas City, MO) which has no base at all near them,
- 851 (Milwaukee, WI) which has ANG bases
- 872 (Scott AFB) which is Active Duty. It is always these three Chapters with the most renewals.

But where are the rest of you AD bases?

You should be able to have one-on-one contact with a lion's share of your membership.

It takes work admittedly, so you should get yourself a committee together and divide up the roster.

And check to see if a person's membership is running out at the end of the current month (February as an example).

Contact all those members and get them to renew before they are dropped. Last year I saw one Chapter lose over 30 members in one month. I am seeing Chapters with members not even renewing thru AFSA. Check with them and find out why they are not renewing.

Are they not renewing because no one in the Chapter has contacted them?

Do they even know when your meetings are?

I found that was the case a few years back with a Chapter in our Division.

Make them feel welcome and when you see a young airman on the roster, **touch base with them.** Those are the ones we are losing. They sign up for a year and then that is it.

Let's all get out there and retain. Last year AFSA had the special Member for Life, the recruiting numbers were way up there, but how many of you contacted your present members and got them to renew? Not near as many.

Three members volunteered 69 Hrs. at VA Hosp. On the 7th Wanda Keifer mailed 1335 stamps to Wounded Vet. Project. The 11th the Chapter donated \$100.00 for Vet. Day. The 14th the Chapter voted to donate \$100.00 to Hope Haven and \$500.00 for patients at the VA Hosp. for Christmas. Then on the 16th 15 members attended the monthly luncheon. We collected \$10.00 for AFEV and \$9.00 for 1/2 and 1/2. Barbara Gregory won Bingo Blackout. The 20th 7 members cut coupons for the Manufacturers Coupon Project for the overseas Commissaries. Member contacted government officials (Governor Scott Walker, Congresswoman Gwen Moore, and Congressman Paul Ryan all of Wisconsin) stating she opposes the closing of two veteran homes. All threeemailed back for her to look at their web sites to see their views on various items. Nothing was mentioned on the web sites of the closing of the two homes. Governor Walker did say that she could contact him by postal mail for a further response to her questions.

Member is crocheting plastic bags to be made into a mat for homeless vets. Mat will be put down with sleeping bag on top of it. This will provide a barrier between the ground and sleeping bag.

Sending toiletries, etc. to deployed 128th ANG members. Working with Homeless Vets in Milwaukee.

Sue Metzger continued to make mats out of plastic bags for homeless vets. Next project will be crocheted winter hats. Canceled stamps to Stamps for the Wounded were mailed out. Coupons were sent to someone who will be sending them overseas to the commissaries to help us out at this time. We have been working to get a POC for the deployed Guardsmen from Milwaukee.

The Chapter sent three care packages overseas. Working with the 128th ANG to make sure our deployed personnel know they are being thought of. Two Chapter members donated winter coats and clothing for a Homeless Vet Shelter in Milwaukee and one member gave a bag of pull tabs that were given to the Girl Scouts for the Pop Tab Patch the girls can earn for collecting pull tabs for Ronald McDonald House.

What you "Ott" to Know

Have you ever read something that was "factually correct" but was "factually incomplete" or misleading?



I've always wondered why so many Airmen are unaware of how their annual basic pay raises are determined, and in turn how we as the Air

Force Sergeants Association could do a better in job in educating the force while being better and stronger advocates for Airmen as well. Perhaps if Airmen knew what they were "supposed" to receive in an annual pay raise (based on Federal Law) they would be more inclined to join and support the one Air Force-recognized National Military Association (NMA) who has fought for all Airmen's Quality of Life for the past 57 years.

Like so many things the Air Force has a pretty solid process in place for immediate supervisors to speak with their Airmen each and every year during their formal feedback process concerning all of their Earned Benefits. It is at this time that each supervisor is directed to provide their Airmen with a copy of the current year's Air Force Benefits Fact Sheet. The current one is dated 3 January 2018 and is also available to everyone on the Air Force Portal at www.my.af.mil. Unfortunately, there are two big problems with this otherwise solid process: 1) Very few supervisors provide their Airmen with a copy and 2) The definition of the annual pay raise falls way short of completeness by failing to mention compliance (or non-compliance) with Federal Law (37 United States Code 1009). Here's what the current Benefits Fact Sheet says: *"The military pay increase for fiscal year 2018 is identified as 2.1 percent. This was based on the Department of Defense's recommendation and President Trump's guidance outlined in the Fiscal Year 2017 Budget proposal sent to Congress."* No mention of the Federal Law.

Oh, it's also interesting to note the official military pay website www.militarypay.defense.gov also falls a little short in their definition of the annual pay raise, but they did do a much better job than the Air Force: *"ECI is the Employment Cost Index, which is a measure of the increase in private-sector wages and salaries. It is calculated by the Department of Labor's Bureau of Labor Statistics and updated every three months. The ECI, reported each October, is used to determine the pay raise for the next fiscal year. The raise was set at ECI + 1/2% for 2000 through 2006. The FY2004 National Defense Authorization Act (NDAA) established that the military pay raise will be equal to ECI after 2006. Of course, Congress can enact raises that exceed these percentages as they did for 2008 and 2009." Again, factually correct but still factually incomplete as it too fails to mention compliance (or non-compliance) with Federal Law.*

Another great source for career development used by every enlisted Airman is of course the Airman Handbook (AFH1), which most folks would refer to as the Professional Development Guide (PDG) or us old timers would call it the Promotion Fitness Examination (PFE) study guide. It is there in the 2015 edition (para 16.3.1.1) where I found this definition: "Annual military pay raises are set by Congress and the President in the National Defense Authorization Act. In the past, the raises have usually been linked to increases in private sector wages, as measured by the Employment Cost Index." Again, a factually correct statement, but factually incomplete as it leaves the reader to think that linking to the ECI is a coincidence, or something "nice to do" as opposed to following (or not) the Federal Law.

What you "Ott" to Know Cont....

Quick history lesson time...I learned something about how the PDG (as it was called then) was written when I served on a PFE test-writing team back in 2009. The Air Force Occupational Management Squadron (AFOMS), now known as the Airman Advance Division (AAD) of the Air Force Education & Training Command (AETC) is responsible for publishing



the new publication every two years. However, they are not the Subject Matter Experts (SME) for the information contained within. Each area of the publication has an Office of Primary Responsibility (OPR) assigned to review and change or update their area every two years...however like anything in life some folks are just better at their job than others.

Here's the "secret" I learned...if you (the reader) finds an error (or simply finds something to be "incomplete") you can make a recommended change. AAD will then track each suggestion to ensure the OPR reviews and accepts the suggestion or rejects with (with applicable supporting reference). So, I thought I'd give it a try and send them an email (pdg@us.af.mil) with a recommended change to add the verbiage about the Federal Law. I never got a response, so I figured my suggestion found its way to the "retired Chief Inbox" (aka delete folder). Imagine my surprise when I recently looked at the 1 Oct 2017 edition and read this updated para 16.3.1.1: "Annual military pay raises are set by Congress and the President in the National Defense Authorization Act. In accordance with Federal

Law (37 United States Code 1009) the January 1 annual pay raise will automatically match the private sector wage increases, as measured by the Employment Cost Index for the previous year. If, because of national emergency or serious economic conditions affecting the general welfare, the President may submit a plan to Congress requesting a lower annual pay raise." My suggested change, verbatim.

So what does all this mean? It means that any of us, each of us, can affect change. Seeing something wrong, something out-ofplace, something "just not right"...if we don't identify it, fix it (if it's ours to fix), or notify those who can fix it to do so...if we do nothing we accept it.

There are three types of people:
Those who make things happen,

- 2) Those who watch things happen,
- 3) Those who say "What just happened?"

What if someone donated enough money to AFSA to cover a free trip to the AFSA PAC but the link was sent out by email on a Saturday and you had to respond by the end of the weekend. Would you get the message and be able to respond in time?

Chances are many of you would not because the email on the AFSA roster is your Air Force work email. I noticed this recently when I updated the email listing I

send out to the leadership of each chapter requesting information for the newsletter. Many of the emails I entered were their Air Force email. Considering I sent my email out on a Saturday many of them would not receive it until Monday, unless Monday was a holiday then it would be Tuesday.

In the past this was not always a bad thing because AFSA has always been part of the Air Force community and that is just how we did things. Even over the last few years the Air Force has simplified things by giving you an email that would transfer every time you moved.

However, things are changing. Air Force servers are becoming more secure and sometimes that means AFSA related emails being sent in are filtered out, especially if they contain attachments. Also some bases/legal offices frown on using your Government email for AFSA business.

This is why AFSA encourages you to list your personal email for your membership information. Most of us have a smart phone and you can easily add your personal email accounts such as Gmail, Yahoo, Comcast, etc. When you do this it is easier to get those important AFSA emails and respond.

I encourage everyone, starting with each person, first starting with the Executive Council of each chapter to update their email on the roster using their personal email. Next, when you sign up a new member or get in a transfer, ask for their personal email and get it to AFSA. After that have your Membership Trustee and those helping them go over the roster and contact the members to do the same.

Replacing an old habit with an new one can help guarantee we can get the AFSA information out in a timely fashion. Also it makes it harder to ignore those emails from Dale Lutzen because now he knows they come straight to my phone.

Once you've embraced this idea then you can move on to the next social media idea to start learning. Trust me, if Bud and Jean, more Jean, can master emails, Facebook and putting together something for the newsletter, then anyone can do it. It doesn't mean you have to learn everything that is out there but at least find a few of the most popular and get involved.

Who knows, if everyone updates at least their email address then just maybe AF-SA will send out a mass email on a Saturday. If not for a free trip to the AFSA PAC then maybe a chance to tour with Jeff Ledoux in his retirement trailer.


