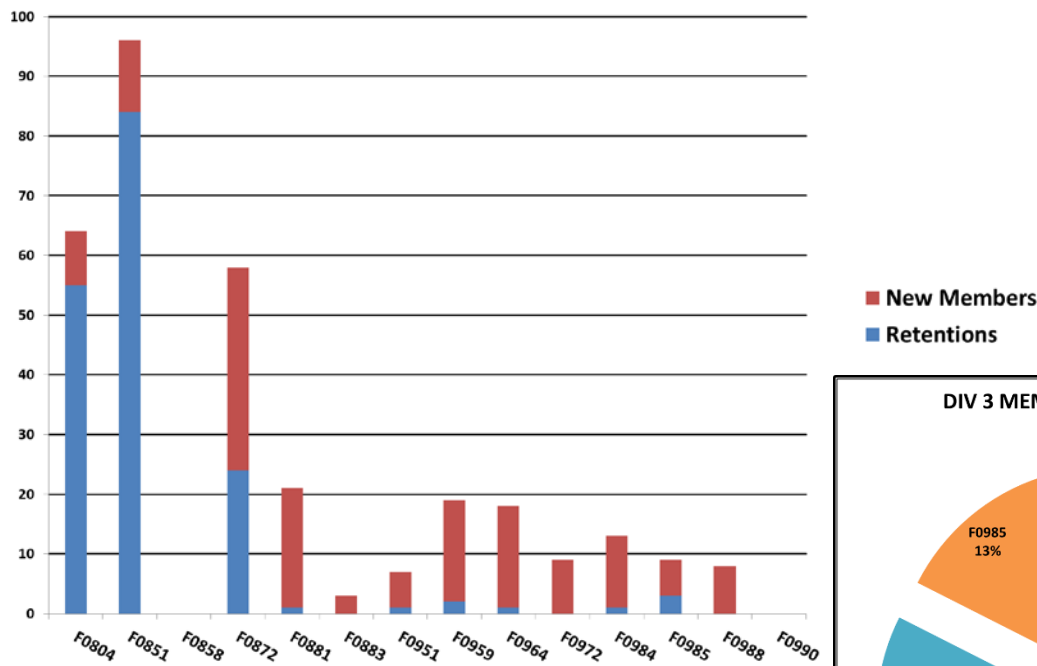
3. Legislation:

- a. **USFSPA:** The U.S. Supreme Court decision handed down on May 15th which will have serious implications for former spouses of veterans, despite providing clarity regarding disability pay from the Department of Veterans Affairs. In a unanimous decision, the Court sided in favor of a veteran who believed he did not owe his ex-wife 20% of that pay, and ruled that state courts cannot order veterans to pay divorced spouses for the loss of his or her retirement pay caused by service-related disability benefits.
- b. **Legislative Awareness Week (LAW):** LAW is set of 1-7 October. This is AFSA's event to raise legislative awareness at the chapter level. Use this event to educate your members on legislative issues and how the legislative process happens.
- c. **President's Budget Proposal:** The President recently released his FY18 Budget Proposal. To read the entire proposal click [here](#).

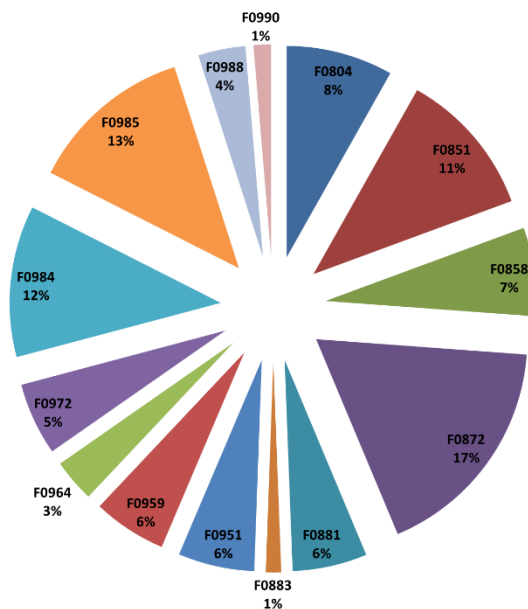
4. Membership:
