REPORTING A DEATH

Access DFAS' Retired Military & Annuitants webpage by a button just below the Request a duplicate 1099R button; have at hand your identifying info and the retiree's name, SSN, manner and date of death, marital status, names/addresses of beneficiaries or next of kin living and deceased. This procedure replaces DFASW Form 9221. Folks reporting also need to call 1-800-321-1080 to report a Survivor Benefit Plan annuitant, if one was named.



VETERANS IN 116TH CONGRESS

The new Congress will begin on 116th and in the meantime members are electing leadership positions. Additionally, the Democrats as majority in the House and the Republicans as majority in the Senate are deciding on legislative priority issues. The 116th Congress has seven fewer veterans than were in the 115th Congress.

- · 95 total veterans in the 116th Congress.
- · 30 are Democrats, 65 are Republicans.
- 18 will serve in the Senate, 77 will serve in the House.
- · 47 served in the military after 2000.
- · 21 served in the military in the 1960s or earlier.
- · 19 are first-time lawmakers.
- · 6 are women.
- · 50 served in the Army, Army Reserve or Army National Guard.
- 17 served in the Marine Corps or Marine Corps Reserve.
- · 16 served in the Air Force, Air Force Reserve or Air National Guard.
- · 13 served in the Navy or Naval Reserve.
- · 1 served in the Coast Guard.

IT'S OFFICIAL: Disabled Vets to See Biggest Raise Since 2012

"Veterans with the highest ratings will see an almost \$100 bump in disability payeach month starting in 2019, the largest increase since 2012.

"That 2.8 percent cost-of-living adjustment (<u>COLA</u>), which kicks in Jan. 1, was made official Monday by the <u>Department of Veterans Affairs</u>. Military retirement, other VA disability benefits, Social Security and federal civilian retirement will see that same increase.

"For veterans with a 10 percent disability rating, that bump brings monthly compensation from \$136.24 to \$140.05 each month, while a veteran entitled to 100 percent disability will go from \$2,973.86 to \$3,057.13 monthly."

AAFES CEO: Serving National Guard, Reserve Must Remain a Top Priority

2020 MILITARY PAY RAISE

Since 1962. Title 37 of the United States Code (USC) has dictated how military pay adjustments will be automatically calculated. U.S.C. Title 37, Chapter 19, § 1009 c reads, "An adjustment made under this section in a year shall provide all eligible members with an increase in the monthly basic pay that is the percentage (rounded to the nearest onetenth of one percent) by which the ECI for the base quarter of the year before the preceding year exceeds the ECI for the base guarter of the second vear before the preceding calendar year (if at all)." On Wednesday October 31, the United States Bureau of Labor Statistics released the ECI calculation that will be used to determine the 2020 military pay raise. That figure is 3.1 percent which, if Congress and the Administration don't move to reduce, would result in the largest pay raise in 10 years. Paragraph e of section 1009 allows the president to cap the pay raise based on a national emergency or serious economic conditions, but he must also notify Congress in writing by September 1 of the preceding year and lawmakers must approve it. We could know the president's intent regarding the pay raise as early as next February when he presents his annual budget proposal to Congress. In the meantime, AFSA will be working with its Coalition partners to begin laying the groundwork to help secure the full. 3.1 percent pay raise that current law provides for.

VA VOWS TO PAY FULL GI BILL HOUSING BENEFITS

Despite a flurry of news stories, tweets and the like this week suggesting otherwise, VA is promising to pay beneficiaries using the Forever GI Bill the exact benefits to which they are entitled under that law. It just may take a little more time than Congress projected to do that. VA officials offering this assurance include, the Secretary of Veterans Affairs, Robert Wilke and VA Under Secretary for Benefits, Paul

<u>Lawrence</u>. VA says the confusion stems from a misleading news report based on an earlier VA <u>announcement</u> regarding these payments.



AGENT ORANGE CONNECTION TO HIGH BLOOD PRESSURE REVEALED

Research showing a stronger connection between exposure to Agent Orange and high blood pressure could lead to additional benefits for tens of thousands of Vietnam-era troops. The study by the National Academies of Sciences, Engineering and Medicine found, "sufficient evidence of an association between exposure to at least one of the chemicals of interest and hypertension." The panel recommended that VA add the condition to its list of presumptive diseases associated with Agent Orange.



Don't forget about the manufacturers' coupons that are sent to the overseas commissaries. They can use them 6-months expired, but I prefer you get them to me no more than 2 months expired due to mailing time, etc. And please sort them by the month.

Cancelled stamps for the Stamps for the Wounded are most welcome. No sorting needed. These are used for therapy for the veterans.

Also, the Box Tops for Education are certainly welcomed. Again, no sorting necessary.
