I would also like to share some points from my President's Report for those who could not make the event.

- Chapter 856 will be merging with Chapter 851, and Chapter 991 will be merging with Chapter 985. This move was required because the chapters had become idle since a solid leadership core could not be found.
- AFSA is currently creating a phone application for Apple and Android devices. This is a key program for the organization if we are going to attract younger members.
- AFSA continues to add more fillable PDF forms to their inventory. Over the last year the AAA form has been converted and updated as required. There has been a positive response from the field for the new fillable forms.
- We have geographically aligned AFROTC and CAP units with our division chapters. This will help to ensure that we can support these organizations better. Special thanks to CMSgt (ret) Mark Clark, Chapter 804 for his assistance in getting this tasking accomplished.







CAPWIZ is also an excellent research tool so you can find out what is happening on Capitol Hill and most importantly, find out if your elected officials are looking out for your best interests.

## What can I do on CAPWIZ?

- Send an email to your elected officials about an issue that is important to you
- Research candidates for public office at the state and federal level
- Research federal government agencies
- Research all legislation currently before congress
- Sign up to receive voting records for your elected officials
- Learn basic etiquette for contacting Congress
- Follow political races for each state and the federal government
- Register to Vote
- Contact local media outlets to let inform the public on matters concerning the enlisted Airman

- Enter your ZIP Code and press GO, CAP-WIZ will load your elected officials
- Edit the letter as you desire or send the preformatted text
- Enter your personal information
- Click on Send Message

In just a few minutes, you have helped AFSA to protect your earned benefits.

If our organization is going to be successful in our lobbying efforts, our membership must be proactive and contact their elected officials. If we do not actively engage our politicians, we run the risk of losing key benefits won during the last 40 years.



#### **Additional Information**

#### **Tuition Assistance**

While International President Yeomans was at the convention, he discussed the tuition assistance effort mounted by AFSA. He explained how AFSA was the only military organization to step up to the plate and take a stand on TA.

While most military organizations remained silent, AFSA felt that our organization had an obligation to our membership to support their pay, benefits, and quality of life. TA is a huge player when it comes to QoL and has a substantial affect on the careers of Airmen.

While there were a small number of AFSA members who felt AFSA was wrong to take a stand, around 99% of comments on Facebook were supportive of AFSA's effort.

AFSA understands why the Air Force made the decision it did, these are hard financial times and hard decision must be made due to shrinking budgets. That said, AFSA was not against the Air Force's decision, AFSA was disappointed in Congress that no action was initially taken to ensure TA was funded even though they were well aware that TA along with many other military benefits would be impacted.

AFSA must continue to support internal AF decisions and work with the Air Force during these hard financial times, but AFSA must also continue to engage congress and not roll over as many other military organizations did during this trying time period.

President Yeomans promised that he would continue to work with HQ AFSA and smartly fight for your benefits because that is the only reason this organization exists, to support its members.

#### **AFSA's Four Pillars**

Anyone who has known me for any length of time knows that I'm an avid supporter of the Air Force Sergeants Association and what the organization does for Airmen and their families. When I've talked to Airmen who aren't members, I get all kinds of responses.

There are those with the glazed over, deer in the headlights look when you start talking about specific legislation in congress, then there are those folks who only think AFSA and other private organizations are for people

Many Airmen don't know about the four pillars of

AFSA. These pillars provide that foundation for what the organization does for Airmen and their families. As we all know, any structure or organization without a solid foundation won't stand long and the four pillars have helped to keep AFSA strong for over 50 years. You can see the AFSA definition of the four pillars here, but I wanted to give a more personal feel for what these pillars mean for our enlisted organization.

The first pillar is Legislation; AFSA calls this the organization's vector. For those not in the flying world, vector is simply the direction of an object. AFSA advocates improvements for Airmen and their families through lobbying Congress on their behalf. As needs arise in



specific areas such as housing, dependent care, pay and benefits, or education, AFSA changes its direction, or vector, to meet those demands.

Think of this pillar as the answer to the folks in the "What's in it for me" crowd. This is where AFSA pays it members back many times over for their yearly dues. One example is increased basic pay; AFSA has been successful along with the Military Coalition since the early 1990s in lobbying Congress for pay raises that are 20% higher than what the DoD recommended.

The second pillar is Membership; AFSA calls this the organization's thrust. Let's face it, without members AFSA would be insignificant on Capitol Hill. AFSA's thrust comes from every member and the more members we have, the more clout our organization has when it is time to lobby for improvements.

AFSA has been very successful over the years, but take a moment and think how much more could be done if one of AFSA's lobbyists could tell an elected official that he represents 50% or 75% of the current sitting Air Force enlisted force or 50% of the retired enlisted force. Sadly, that isn't the case and in 2011, only 14% of the Active Duty force were members of AFSA. This low membership statistic hurts our thrust when fighting for benefits, especially those that directly affect Active Duty Airmen.

Take the recent case of Tuition Assistance cuts, the grassroots efforts by AFSA members were critical in making sure those cuts were curtailed by Congress. Because so many Airmen stood up to be heard, our thrust was able to push this legislation through Congress. For every Airman who takes just one class, the out of pocket savings would be more than enough to cover several years of AFSA membership.

The third pillar is Communications; AFSA calls this the organization's glue. Every organization requires an effective communications system and AFSA uses numerous methods including the HQ AFSA website along with Division and Chapter websites and other online tools such as Facebook and Twitter.

AFSA also uses an email system to deliver informative emails through AFSA's chain of command down to each member along with the AFSA On Call weekly newsletter.

The final method, word of mouth, is used at our monthly chapter meetings to ensure as many members are informed as possible. Part of this communication system is the responsibility of the member to ensure they are informed.

Members should regularly visit their Chapter, Division, and HQ AFSA website if they are connected to the internet. If they do not have an electronic means, then members should coordinate with their local chapter for an "old school" solution. Regardless, AFSA works with the members to make sure they are informed as much as possible.

One great example of how critical communication is when a member retires and moves away from a military base. Once a member has little to no daily contact with the military or their AFSA Chapter, it can be difficult to stay abreast of changes in retirement benefits. If AFSA had been unsuccessful with the last two administrations and failed to defeat the large proposed TRICARE fee increases, a



retiree might have found out about this once their monthly allotment changed from approximately \$35 per month to over \$100 per month. This is why it is so critical to continue your AFSA membership after retirement, the information about your benefits alone is worth the annual membership fee.

The final pillar is Fraternity; AFSA calls this the organization's bond. There is an old saying that you have civilian friends for an assignment but military friends are for life. There is a lot of truth to that, as Airmen we grow bonds of friendship that last a lifetime. Even when you meet someone and you learn they were a Blue Suiter, you can easily strike up a conversation because you have the same experiences.

When I retired from the Air Force, there were two things I really missed, the people and the money. The nice thing was I still received a check from DFAS every month so that made up for the money to some extent and AFSA has helped to make up for the people.

Being a member of AFSA allows me to keep in contact with Airmen and it also allows me to continue with the best part of being a SNCO by letting me continue to take care of Airmen.

I really enjoyed the AFSA Division 3 PAC this year, I enjoyed seeing some old friends and made some new ones. The one thing all of us have in common is that bond of wearing the uniform and being a part of the same fraternity of Airmen.

Don't tell Doc, but I'd pay a lot more than \$25/year to be a member just because I can continue to serve my nation, my Air Force and my fellow Airmen by being a member of AFSA.
